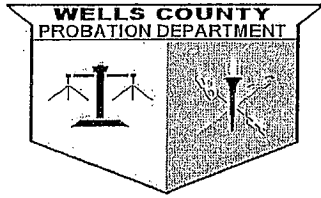


# Counseling Programs
